#### Asian Americans in U.S.

- 17.3 MILLION U.S. residents are of Asian descent.
- 10.2 MILLION (60%) Asian Americans are foreignborn.
- 46% growth in the Asian American population between 2000 and 2010 census
- 15% of people identifying themselves as Asian in combination with one or more other races.
- 24% of the Asian population is under the age of 18 years, while 10% is over 65 years.
- **DIVERSE COMMUNITY** comprising over 32 countries of origin, cultures, religions, time in the U.S., age, English proficiency, and socioeconomic status.



### **Asian Americans in New York City**

The Asian American population is 1.6M (8%) of New York State and 1.1M (14%) of New York City.

7 out of 10 are foreign-born

1 out 2 Asian Americans speak English less than "very well"




1 out of 8 does not have health insurance

1 out of 4 is live in poverty





### **Asian American Children in NYC**

1 in 8 children (229,587) in NYC are Asian Americans

AA children only racial group that saw an increase in population in last Census (16%)

Population growth mostly among US-born Asian children

Increase mostly from: Chinese, Bangladeshi, Pakistani, and Japanese children






#### **Asian American Children in NYS**

AA child population grew by 53% in upstate counties and 43% in suburban counties.

AA children make up 22% of upstate and 28% of suburban AA population.

Increase in number of refugees from Myanmar and Bhutan settling in several cities in New York such as Buffalo, Utica, and Syracuse.

Without growth of Asian population, NYS would have had an overall decline in the population in last decade.





#### **Asian-Owned Small Businesses**

- NY had the 2<sup>nd</sup> highest state (196,852)
  - Among cities, NYC having the largest number of Asian-owned business (153,885)
  - Among counties, Queens County was 2<sup>nd</sup> (68,606)
     behind Los Angeles County
- NYC Asian-owned business contributed \$38B in sales and employed 160K in 2007
- Highest # of firms were among Chinese (71,613),
   Indians (34,227), and Koreans (17,954)
- Overrepresented in accommodation & food services, transportation and warehousing, and wholesale trade




#### The Case for Health Reform

- 2.3 million Asian Americans are uninsured nationally. Highest among Bangladeshis, Pakistanis, Koreans, and Cambodians.
- 1 in 8 Asian Americans in NYC has been uninsured.
   Overwhelmingly, majority (83%) of uninsured AA in NYC are foreign-born.
- Nationally, while 72% of Asian Americans receive health care through their employers, many of the remaining are selfemployed, working in small businesses or in cash-based industries that are less likely to offer health benefits.
- Healthcare access problems are exacerbated in Asian American communities by immigration status, language barriers, cultural stigmas regarding public benefits, and low utilization of primary and preventive care.


