Universality

Everyone is included and can meet their healthcare needs.



Comprehensive

Full benefits and choice of provider



Equity

Funded fairly based on ability to pay. Quality care guaranteed for everybody



Accountability and Transparency

Participation

Everyone has a meaningful voice in decisions that impact us all.

ANY private health insurance pays or deductibles









New York Health Act- Financing

- Existing funds from Medicare, Medicaid, CHIP, ACA
- Progressive payroll tax based on ability to pay and tax on investment income
 - o 80% paid by employer
 - o 20% paid by employee
 - First \$25,000 of income is not taxed
- Don't be scared by the word "tax" this payment would replace <u>all</u> out-of-pocket healthcare costs (premiums, co-pays, deductibles, etc.)





Transition



- Fully implemented 2-3 years after passage of NY Health Act
- Apply for federal waivers (can be implemented with or without)
- Establish Board of Advisors
- Establish Regional Advisory Councils
- Establish Commission to handle implementation and enrollment
- Set the rates for reimbursement and tax brackets
- Start paying for healthcare services

SENATE


Have been at 31 co-sponsors (32 = majority) 2021 Democratic Supermajority
